This standing authority shall be valid for a period commencing from the date of GNS's and GNF's approval to this authority up to and including the last day of the eleventh (11th) month of the date of such approval and shall be deemed to have been renewed for subsequent period not exceeding 12 months with the same terms and conditions as specified in this standing authority either with the Client's written consent or if the Client does not object to renewal before its expiry given that GNS and GNF have given at least 14 days prior written notice reminding the Client of its impending expiry.
